

- The role of education in self-protecting democracy shall not be overlooked

Messages on HEIs and European values

- As Europe faces new challenges, and European values such as peace, democracy, freedom and human rights are targeted by our adversaries, the European way of life has to be protected.
- This role of HEIs is also present in the European Strategy for Universities.
- The societal responsibility of HEIs should complement their other roles in research, learning and teaching.
- The EU/EEA member states also support Ukrainian government and HEIs, and they are committed to provide any
 resources, Ukrainian refugee students, teachers and researchers may need.

Key messages from both events

European Quality Assurance and Recognition System

• The main aim is to promote quality culture at HEIs, and to facilitate further transnational cooperation.

Automatic recognition within European Education Area

- A result of better connection of QA in Higher Education and recognition systems
- All graduates within European Education Area may benefit, as the degree obtained would be recognised in any Member State.

European Higher Education Observatory

- Monitoring of implementation of University Strategy
- An "one-stop-shop," at which various aspects of quality could be compared
- HE scoreboard, 29 criteria identified
- Roadmap prepared by Technopolis, the needs of various stakeholders are being discussed. (European Commission, Member States, HEIs, etc.)



Key messages from both events

Microcredentials

During parallel sessions, the following aspects were discussed:

- need for legislative framework, QA cooperation with QA agencies;
- facilitation of the ongoing and emerging development of micro-credentials within formal learning settings, as well as non-formal and informal learning settings;
- support of the quality and transparency of micro-credentials;
- promotion and support of effective experimentation, cooperation, governance and partnerships between HEIs, employers, local organizations and authorities and other relevant stakeholders;
- integration of micro-credentials into both education and training systems;
- provision that information and advice on identifying and selecting micro-credentials is incorporated into lifelong learning guidance services.



Key messages from both events

The European framework for attractive and sustainable careers in higher education

- an innovative academic career policies, to tackle the rigidity of academic system and career patterns;
- mechanisms addressing persisting lack of parity of esteem between different academic paths;
- ensuring that career development is supported adequately;
- continuing effort to eliminate gender gaps and biases;
- improvement of working conditions;
- providing a wider range of European mobility opportunities.
