# Overview of the landscape of providers



- No comprehensive mapping on all the non traditional providers of HE programmes across the EHEA yet
- The number of micro credentials, measured by number of courses at 6 main learning platforms, rose for more than 200% between 2018 and 2022 (OECD, 2023)
- Cedefop (2023) shows that variety of actors such as public organisations, companies and employment services, offer programmes at higher education level
- Employees surveyed (N=384) had a stronger preference for micro credentials offered by accredited providers (62%) and to the ones being offered as part of the national formal offer of education and training (48%) (Cedefop, 2023)

# Defining "Other providers" in DEQAR



a) Higher education institution: an entity that has <u>full degree awarding powers</u> recognised by at least one national authority

b) Other provider: an entity that has provides learning opportunities at HE level, but does not have full degree awarding powers itself





# Overview of the landscape of micro credentials



- No comprehensive dataset of all micro-credential offers in the EHEA yet
- Few national registers exist either as a part of general list of HE provisions or independently (10 EHEA systems) (ENQA, 2023)
- Web portals tend to provide limited information as to how specific credentials are linked to occupational fields. In addition, it is not always clear whether micro-credentials are a pathway to a qualification at a higher level (Cedefop, 2023)
- Accreditation and certification as crucial elements in trusting the MC; More trusted when related to national formal offer (Cedefop, 2023)

# Defining a micro - credential



### A study programme:

- a) Related to **EQF/ISCED level (5), 6, 7 or 8** OR **QF EHEA level short, first, second, third cycle**
- b) Does not lead to a full (recognised) degree
- c) Consisted by a workload expressed in ECTS in the range of 1 and 59 ECTS credits





# Validation rules – required fields



- Newly required for all programmes (i.e. except institutional reports):
  - degree outcome
  - qualification level (QF-EHEA/EQF/ISCED)
- Required for programmes with degree outcome "no" (= micro-credentials, other provision):
  - Workload expressed in ECTS
  - Details on assessment or certification

### Validation rules – constraints



- Reports not covering any EHEA higher education institution (e.g. only non-European HEI or other provider):
  - Status must be "voluntary"
- Programme-level reports covering only other providers:
  - Degree outcome must be "no" (= cannot lead to a full recognised degree)

## Flagging - high level / red



NB: The purpose of flags is to bring a report to EQAR's attention. Do not change the data you entered/uploaded if it is correct, but wait for EQAR Secretariat to have checked the report.

Status given as "part of obligatory EQA system", but the agency does not have official status (according to EQAR's information) in any legal seat country of any higher education covered by the report.

NB for mixed reports: agency must have official status **in one of the higher education institutions' countries**, the status in the other providers' countries is not relevant and will not make this check pass

# Flagging – low level / yellow



NB: Flags with a yellow flag appear normally on the public DEQAR website, they are only informative for the EQAR Secretariat to take note of the report.

- Report covers a provider with a legal seat (or programme) in a country where the agency has not operated before
- Programme country does not match any location country of the provider(s).
- Status is "voluntary" and programme's qualification level is not listed as qualification level for any of the higher education institutions covered
- PDF file could not be downloaded from the URL that was specified, or still has to be uploaded (using the specific API endpoint)
